## GENERAL CONDITIONS FOR PITCHES/RENTALS

Any request of rent has to be signed and accompanied by an advance of 30% of the total amount of the stay and expenses specified on the contact.

The booking is nominative.

The booking becomes definitive after receipt of the advance.

Terms of payment are defined : Booking fee (17€) will, in no case, be refund.

### EARLY DEPARTURE – DELAYED ARRIVAL

**In case of an early departure, and whatever the reason, the total amount of the stay will be kept by the campsite (only for bookings). The manager has the right, in case of an early departure or an annulation, to release the pitch/rental. No reduction will be given in case of delayed arrival.**

For any modification of the dates of your stay as planned in the contract, the same place can not be guaranteed.

Any modification that may lead to a variation of the amount of the rental, upward or downward (changing of dates, affecting the pricing period, change number of occupants ...) must be told no later than the day of arrival.

The client must arrive on the day written on his contract. Any delay must be indicated. Beyond a period of 24h after the scheduled date and without any news from the client, the manager has the right to cancel the the rent or the camping place.

### CANCELLATION :

Any cancellation has to be made by letter or by mail.

-More than 30 days before your arrival, the amount of the advance remains acquired at the campsite

- Less than 30 days before your arrival, the total amount of your stay, and the booking fee, are kept.

**To obtain a possible compensation , we invite you to subscribe a cancellation or interruption of stay insurance. This can be done on : [www.campez-couvert.com](http://www.campez-couvert.com) (see the full conditions on our website, on request by mail or on the insurance website).**

### PAYMENT OF YOUR STAY

**The total amount of your stay has to be paid 30 days before your arrival (credit card or bank transfer).**

**A stay reserved less than 30 days before the arrival date, payment by bank transfer or credit card the day of the reservation.**

**The resident tax, as well as the departmental tax, are fixed and collected by the local authorities. The client has to pay it during his stay.**

Services performed not previously included in the contract, will be subject to additional billing.

### ANIMALS

**All dogs** required to stay at the campsite, must be vaccinated and tatoed. They are limited to 1 per rent. The client must show the dog's vaccination record at the reception. Dogs of 1<sup>st</sup> and 2<sup>nd</sup> category are not accepted.

All persons staying or visiting the campsite, are required to respect the internal rules of the campsite. The rules are posted at the entrance of the campsite and can be given on request at the reception.

### RENTAL CONDITIONS OF MOBILE-HOMES AND CHALETS :

Rentals are available as from 4pm and departure is before 10am (In July and August).

During medium and low season : contact the reception please.

For the rent of any Mobile-Home or chalet, **a security deposit of 190€** will be asked at your arrival. The security deposit will be fully refunded if no damage has been found and if the place is in a state of excellent cleanliness. Any damage will be subject to an indemnity that will be deducted from the amount of the security deposit, as well as the final cleaning if necessary.

The client is responsible for any damage occuring by his act. He must have subscribed a civil liability insurance.

All information about the campsite (Inventory, prices, rental) are available on our website, or by post letter by a simple request.

#### Opening hours of the reception :

Pitches are available as from 12am and have to be released before 12am. The balance of the invoice has to be paid the day before departure.

The gate of the campsite is open from 07am till 11pm . No derogation allowed. Between 11pm and 07am, only pedestrian acces is allowed.
